## Organizational structure:

Executive committee of 5 members, Nace ( national Association of Executives) Chain Leaders ( General Assembly and Congress (annual), Executive committee Of President, 2 vice presidents ( Hotels and resturants), treasurer, secretary, Board consisting of Executive committee members in addition to 7 regional vice presidents (North America, South America, Asia and pacific,Africa, Europe, balkans and Middle East)5 members of National Hotels Assoiation and 5 members from Chain leaders, one member representing restaurants, one member representing independant hotels. Board meet 3 times per year physically. Executive committee meets whenever action is needed, financial committee meet three times a year . Nace and Chain leaders meeting meet twice a year comprising members representing national and international hotels chain and restaurants chains which must be monitored and lobbied and to discuss priority issues affecting national associaiton members in their respective countries and directs the issues which require international monitoring and lobbying. All members can attend the congress held annually in a different country where all members can participate or appoint representatives to serve on Global councils and task forces. Three award are distributed each year. One for Hotelier of the century ( 50 yars of services to the Industry ) one Crystal Award ( independant hotel only for performance ) nd Emerald Hotelier of the year (new) for anyhotel who do respect the IHRA criteria for sustainable development with three levels (One Emerald) for respecting at least 50% of the criteria, (2 Emerald) for respecting at least 75% of the criterias and ( 3 emeralds ) for respecting more than 75% of the criterias. Classification is valid for 2 years . hotels are inspected evry 2 years to renew their classifications. 2 foundations, One FOUNDATION FOR THE FUTURE, to help eduaction and training services for emerging markets countries. Foundation for a Green World) (new) to help Public sector fighting the Climate change issues and have an earth lung atmosphere.
